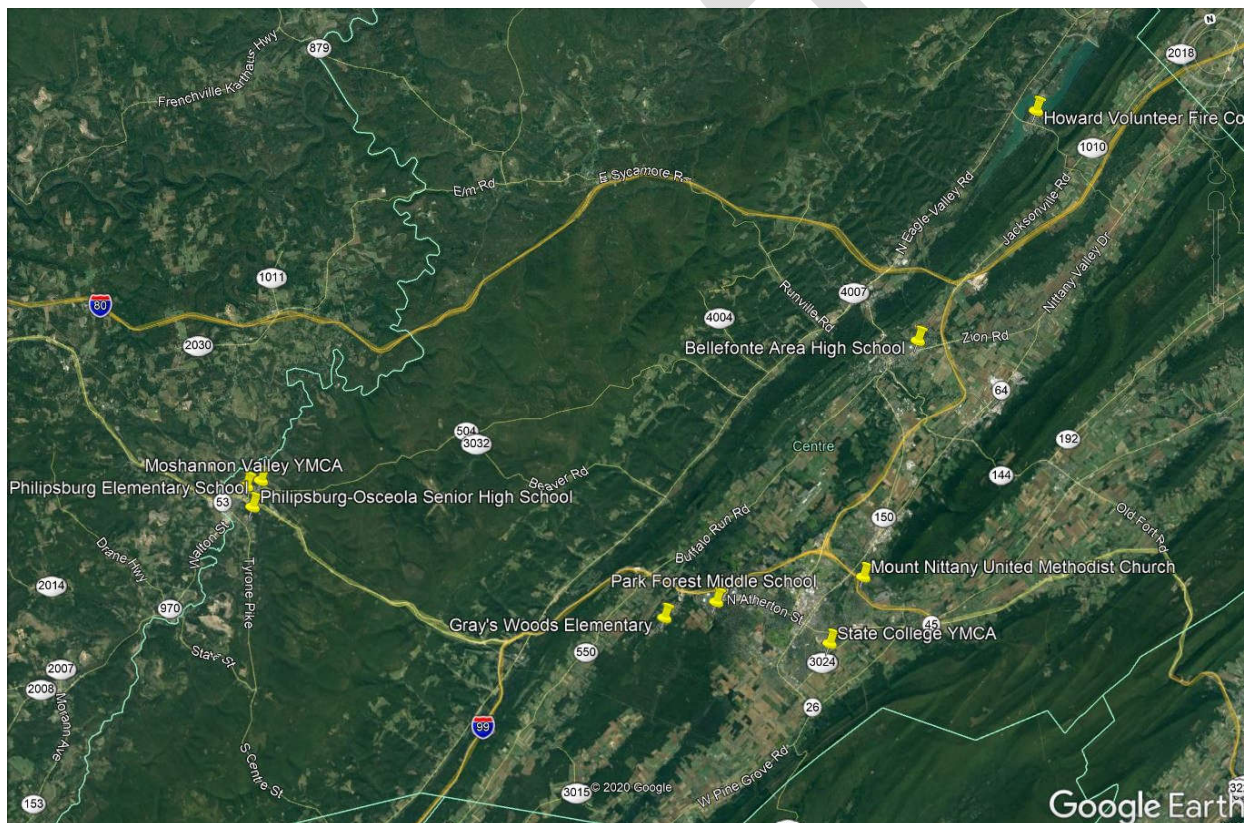

Heavy rains over central Pennsylvania have caused flooding in Centre County in Howard, Philipsburg, and State College. Many people in these areas have been displaced and the ARC has opened a number of shelters. Regular public safety communications systems have been over taxed and the loss of several cellular towers has resulted in the loss of cell service for extended periods.

### 7. Current and Planned Objectives:

#### THIS IS AN EXERCISE:

1. Set up amateur radio communications among the shelters on a VHF network to relay occupancy and supply needs to ARC HQ in Pittsburgh using HF networks.
  2. Establish amateur radio links with surrounding counties to assist with their relays.
  3. Set up Skywarn activity to communicate local conditions to NWS CTP and relay information from NWS to the field.

2. Mifflin and Huntingdon County links may generate messages relevant to intercounty information needs.
3. Skywarn may take and relay messages of actual WX conditions from all stations.
  - a. NCS is identified as the Skywarn relay in the WPA outline. That may be changed to the Skywarn station (K3HOT) depending on circumstances.

Using standard PEMA HF frequencies (see ICS-205) set up HF stations that can communicate with PEMA HQ in Dauphin County and ARC HQ in Pittsburgh.

Set up a Skywarn link to relay information in and out of NWS CTP. To the extent possible communicate on VHF with as many of the NWS CTP counties on VHF
